only those costs reimbursed, the court can ensure a complete remedy and largely maintain its existing precedent.

Although Atlantic Research stands in the place of Aviall by refusing to address an important contribution question, it has in a similar fashion set the stage for a possible change in the law. For just as Aviall resulted in an equitable conclusion for PRPs performing voluntary cleanups, so can Atlantic Research conclude for PRPs entering consent decrees. And with a number of the lower courts already recognizing some of the problems and solutions addressed herein, the future of CERCLA's contribution scheme remains bright.
