### ORDER ESTABLISHING SUPPLEMENTAL BAR DATE FOR ADULT CLAIMS

Upon the motion [Docket No. 1037] (the "Motion") of The Roman Catholic Diocese of Syracuse, New York (the "Diocese"), for entry of an order establishing a supplemental bar date for Adult Claims (defined below) and granting related relief; and all objections to the Motion having been resolved or overruled; and upon finding that: (a) the Court has jurisdiction to consider the Motion pursuant to 28 U.S.C. §§ 157 and 1334; (b) that venue of this Chapter 11 Case and the Motion in this district is proper pursuant to 28 U.S.C. §§ 1408 and 1409; (c) that this matter is a core proceeding pursuant to 28 U.S.C. § 157(b); (d) the relief requested in the Motion is in the best interests of the Diocese, its estate, creditors and other parties in interest; and (e) proper and

adequate notice of the Motion has been given under the circumstances and, except as otherwise ordered herein, no other or further notice is necessary; and after due deliberation thereon; and good and sufficient cause appearing therefor;

#### IT IS HEREBY ORDERED THAT:

- 1. The Motion is hereby GRANTED as set forth herein.
- 2. Notwithstanding any deadlines set forth in the *Bar Date Order Establishing April* 15, 2021 as the Deadline for Filing Proofs of Claim and Approving the Form and Manner of Notice Thereof [Docket No. 214] (the "Bar Date Order"), any Sexual Abuse Proof of Claim which asserts a Sexual Abuse Claim against the Diocese arising from abuse which is alleged to have occurred on or after the date on which the Sexual Abuse Claimant achieved the age of eighteen (18) years and which, prior to the enactment of the Adult Survivors Act (S.66A/A.648A), would have been subject to a statute of limitations defense under New York law (an "Adult Claim"), shall be deemed timely, with respect to such Adult Claim only, if it is actually received by Stretto, the Diocese's Claim and Noticing Agent on or before January 17, 2023, at 11:59 P.M. (prevailing Eastern time) (the "Supplemental Bar Date"). For the avoidance of doubt, the Supplemental Bar Date shall be binding upon all parties in interest in this case notwithstanding that the applicable period of time for the commencement of lawsuits under the Adult Survivors Act extends beyond the Supplemental Bar Date.
- 3. Except to the extent modified by paragraph 2 above, all terms and provisions of the Bar Date Order (including, without limitation, those provisions of the Bar Date Order relating to the Confidentiality Protocol and the form and manner of submission of Sexual Abuse Claim Proofs) shall remain in effect and shall apply with respect to all Adult Claims. Nothing in this

Order shall be deemed to modify the Bar Date Order in any way with respect to any claims which are not Adult Claims.

- 4. For the avoidance of doubt, nothing in this Order shall require any Sexual Abuse Claimant who has previously submitted a Sexual Abuse Proof of Claim asserting an Adult Claim in accordance with the Bar Date Order to file any additional proofs of claim.
- 5. The form of Supplemental Bar Date Notice attached hereto as *Exhibit 1* (the "Supplemental Bar Date Notice") is hereby approved.
- 6. The form of Publication Notice attached hereto as *Exhibit 2* (the "<u>Publication Notice</u>") is hereby approved.
- 7. As promptly as possible following entry of this Order, the Diocese shall serve (i) the Supplemental Bar Date Notice (ii) a copy of this Order (without exhibits or schedules), (iii) a copy of Official Form 410, and (iv) a Confidential Sexual Abuse Claim Supplement by first class mail upon each person, or their respective counsel, who the Diocese knows to have asserted a possible Adult Claim and who has not already filed a proof of claim in this Chapter 11 Case. The Diocese shall also serve a copy of the Supplemental Bar Date Notice upon the Office of the United States Trustee, counsel to the Committee, and any person who has filed a notice of appearance and requested service of papers in this Chapter 11 Case pursuant to Bankruptcy Rule 2002.
- 8. In addition to providing direct notice as set forth above, subject to applicable publication guidelines and submission deadlines, the Diocese shall cause the Publication Notice to be published once in either *The New York Times* or *USA Today* and twice in each of *The Post Standard*, *The Rochester Democrat & Chronicle*, *The Observer-Dispatch*, *The Press & Sun*

Bulletin, The Albany Times Union, The Catholic Sun, North Country Catholic, and The Evangelist with such publication to occur as promptly as practicable.

- 9. In addition to the foregoing publication, the Diocese shall take the following additional measures to disseminate information relating to the Supplemental Bar Date as soon as practicable following entry of this Order.
  - a. Beginning not later than November 15, 2022 and continuing through at least the Date of the Supplemental Bar Date, the Diocese will cause prominent, one-click links to the Sexual Abuse Claim Notice Package to be posted on the case management website maintained by Stretto with such links to be pinned at the top of the website.
  - b. Beginning not later than November 15, 2022 and continuing through at least the Date of the Supplemental Bar Date, the Diocese will cause Stretto to maintain a telephone number which may be used by claimants to ask questions or to request copies of the Sexual Abuse Claim Notice Package, or parts thereof.
  - c. Beginning not later than November 15, 2022 and continuing through at least the Date of the Supplemental Bar Date, the Diocese will cause links to the Sexual Abuse Claims Notice Package to be prominently posted on the Diocese's website homepage with such links to be pinned at the top of the website. Not later than November 15, 2022 and again on December 15, 2022, the Diocese shall post notice of the Bar Date on its Facebook and Twitter accounts.
  - d. The Diocese will mail a copy of the Publication Notice to each parish and ministry (except primary and secondary schools) overseen by the Bishop of the Diocese with a request and recommendation to display the Publication Notice in a prominent place until expiration of the Supplemental Bar Date and to publish a copy of the Publication Notice in parish bulletins.
  - e. The Diocese will mail a copy of the Supplemental Bar Date Notice to the following on the Diocese's stationary and shall request that the party post the Supplemental Bar Date Notice in a prominent place until the expiration of the Supplemental Bar Date:
    - i. the Attorney General of the State of New York; and
    - ii. For each of the counties of Broome, Chenango, Cortland, Madison, Oneida, Onondaga, Oswego:
      - aa. the district attorney's office;

bb. sheriff's office;

cc. at least one public health agency (if any); and

dd. at least one substance abuse agency or hospital (if any).

Date as approved herein fulfills the notice requirements of the Bankruptcy Code and Bankruptcy Rules and is reasonably calculated under the circumstances to comply with the due process rights of all parties under the standards established in *Mullane v. Central Hanover Bank & Trust Co.*, 339 U.S. 306 (1950) and *Hecht v. United Collection Bureau, Inc.*, 691 F.3d 218 (2d Cir. 2012) and that no other or further notice of the Supplemental Bar Date is required.

- 11. Nothing contained in this Order is intended or should be construed as a finding as to the validity of any claim against the Diocese, and all parties retain all rights to dispute any claim on any grounds. All parties retain the right to dispute, or to assert offsets or defenses to, any claim (whether or not reflected on the Schedules or any amendments thereto) as to amount, liability, classification, or otherwise, and to subsequently designate any claim as contingent, unliquidated or disputed.
- 12. The Court retains jurisdiction to hear and determine all matters arising from or related to the implementation, interpretation and/or enforcement of this Order.
